Community health centers are once again being held up as the solution for expanding access, improving quality and containing costs across the health system.

The expectations are considerable: double the number of patients we serve in 5 years; initiate a host of new services; comply with ever more complicated regulations; and take on more risk through new payment reform models that will radically alter how health care is delivered and paid for in Massachusetts and across the country.

Although the shape of things to come is far from clear, consensus among policymakers, consumers and healthcare and business leaders has never been clearer: all agree that the current fee-for-service-driven health care system isn't working. Movement toward something different is imminent and community health centers will need to lead the way or be left behind.

That means understanding and addressing the financial, clinical, social, managerial and legal risks of a new care system, while engaging in efforts to fight off threats to uncompensated care, public health funding, behavioral health, dental care and the Medicaid program. It also means promoting our longstanding model of patient-centered care — a model that has earned us the respect and new-found interest of the health policy and medical communities alike.

Part IV: Dental Sealants

Despite the evidence that dental sealants are effective in preventing caries in children, sealant use among lower-income children who are at highest risk for developing caries — persists at around 30 percent, well below the Healthy People 2010 objective of 50 percent. Better documentation of the effectiveness of sealants could go far in removing barriers to their use, particularly in communities served by health centers. The session will consider the barriers to sealant utilization and provide attendees with a roadmap for expanding access to oral health through quality improvement projects; increasing sealant use in children with the help of quality improvement tools; and establishing collaborative efforts across a health center's dental, medical, and outreach departments to reduce oral health disease in pediatric patients.

Transforming Care Delivery: Health Plan/Delivery System Partnerships Challenges facing community health centers trying to sustain high-quality care while addressing costs are also shared by health plans serving the same patient populations.
